I fully understand that skating involves risks of serious bodily injury, including permanent disability, paralysis, and death, and that these and other risks may be caused by Skater's own actions, or inactions, those of others participating in the event, the conditions in which the event takes place, or the negligence of the Releases named below; and that there may be other risks either not known to me or not foreseen at this time; and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of Skater's participation in the activity.

I hereby release, discharge, and covenant not to sue Deep Freeze Skating Club Boosters, their respective administrators, directors, agents, officers, volunteers, and employees, and any sponsors and advertisers of any sanctioned event in which Skater participates (each considered one of the Releases herein) from all liability, claims, demands, losses, or damages on Skater's or my account caused or alleged to be caused in whole or in part by the negligence of the Releases. This release waiver of liability and express assumption of risk agreement does not apply to any liability, claims, demands, losses, or damages arising out of the gross negligence of, or intentional, willful or wanton misconduct of Releases.
